

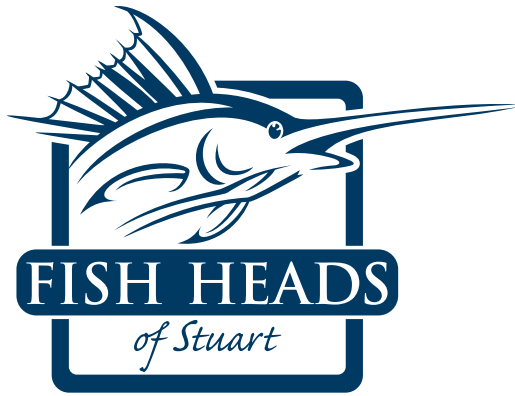

## **The Quickie Tournament Rules**

Safe boating practices expected throughout the entire tournament

- Determination to fish is at the sole discretion of captain and crew
- All boats must carry appropriate Liability Insurance
- Boats/anglers must comply with all state/federal fishing regulations
- Tournament Channel is 80; Alternate Channel is 74
- Check-Out upon departure via VHF or Cell Phone (Text Ok) - (772) 341-7323
- Check-In upon return via VHF or Cell Phone (Text Ok) - (772) 341-7323
- Northern Boundary - 27.55'.00 North (~ 3.5 miles north of Sebastian Inlet)
- Southern Boundary - 26.25'.00 North (~ 5 miles north of Boca Raton Inlet)
- Dead Bait Tournament - Tournament Approved Circle Hooks - Single Hook Rigs
- Hook & Hand permitted
- Winner determined by Total Number of Releases by Time
- Reels must be spooled with 20lb or lighter monofilament - backing OK
- Lines In - 8:30am/Lines Out - 3:30pm - Call hooked fish 15m. prior to lines out
- Each release must be immediately radioed to Tournament Committee via VHF
  - Phone may be used as backup and will be relayed back over VHF
  - Tournament Committee will recognize Release with catch number and official time

**The Quickie Tournament Rules (cont.)**

- OFFICIAL RELEASE - Swivel/Leader touches the rod tip and/or Mate controls leader
- VIDEO RELEASE - contiguous VIDEO showing the Sailfish, RELEASE, and Daily ID
- DAILY CATCH LOG (signed by Captain) and VIDEO submitted each day:
  - 7pm on Tuesday (12/16) and 6pm Wednesday (12/17)
  - Cell Phone video or emailed video OK to submit throughout the day
- Allegations of violation of any of the above rules may be submitted only by an owner and/or captain of a registered tournament boat and must be submitted in writing
  - Any protests must be submitted to Tournament Rule Committee by 6:00pm of the day of the alleged infraction, accompanied by a \$250 protest fee
- In the event of such an allegation, the Tournament Directors will have the sole and exclusive responsibility to investigate the alleged incident and to rule as to whether any violation materially aided the angler, crew, or vessel, or otherwise affected the outcome of the tournament
  - Any subsequent penalty will be solely at the discretion of the tournament directors and shall be final
  - In all cases, registrant and their respective crews agree to be bound by the ruling of the tournament directors
